

# ODE EMIS Conference Call Summary

7.29.19 Notes provided by Mary Myers (LACA), Naja Bailey (META) and Catherine Wright (NEONET)

**FY20S Retention** – Part way through the FY19S Retention collection last year, ODE removed JVSD's from the collection and ODE is planning on keeping them out of the Retention Collection. In general, it is the home districts should report these students, so there is no need for JVSD's to report them also.

**Appeals** – Appeals applications for FY19S and FY19A for EOC and Grades 3-8 assessments were due Friday last week. The LEA's with approved appeals will have until **July 31 at 5:00 pm** to submit data. There will be no extensions so data can be processed Wednesday night and sent to SAS for calculating the Value Added portion of the Local Report Card. If districts have applied for the appeal and were approved, ODE is adding districts to the resubmission lists daily.

**FTE Reports** – The FY19 FTE reports are still being updated since FY19 Final Calendar collection is still open. Also, the FY19 CTE FTE reports are still being updated since FY19 Final Staff/Course collection is still open. About two weeks left on these collections.

**FY20 collections** – The FY20 Initial Calendar, FY20 Retention and the FY20 SCR Collections are already open. Later this week, ODE is planning on opening the FY20 SOES Beginning of the Year and FY20 SOES Student Contact. ODE is starting to look at the FY20 collection data and start populating the SOES module in ODDEX soon.

**Data Collector** – ODE is getting closer to the new release of the Data Collector, hopefully sometime this week. They still have some tables to set up around categories, etc.

## **Q&A**

**Q:** Now that appeals are over, if districts find an issue, can they contact the Office of Accountability to get a watermark?

**A:** Yes, they can get a watermark. Districts will need to contact the **Office of Data Quality** to request the watermark, but there is nothing wrong with also notifying the Office of Accountability.

**Q:** Do you know if a new ACT vendor file was released on July 22?

**A:** No, we don't have the release schedule for vendors

**FY19A CTE Assessments** – ODE published an update to the new CTE assessment collection. The update version has a missing list based on the vendor data. This will be published in the NEWSFLASH tomorrow. At this point, the list is only based on vendor files; we will most likely be adding additional students to the missing lists for enrollment and Career Tech courses where a Score Not Reported (SNR) code or assessment should be reported. Collection closes in October, so right now we are focused on LRC data, and this doesn't have an impact until next year's LRC. For those districts with CTE courses, remember to check those missing lists.
